### **KIOWA COUNTY HOSITAL DISTRICT CONTINGENT REQUEST FOR INCREASE MILL LEVY**

SHALL KIOWA COUNTY HOSPITAL DISTRICT'S TAXES BE INCREASED BY THE IMPOSITION OF AN INCREASED OPERATING LEVY NOT TO EXCEED 23.36 MILLS BEGINNING IN TAX COLLECTION YEAR 2026 AND CONTINUING THEREAFTER UPON THE THEN CURRENT ASSESSED VALUATION OF ALL PROPERTY LOCATED WITHIN KIOWA COUNTY HOSPITAL DISTRICT IN ORDER TO INCREASE OR IMPROVE LEVELS OF PUBLIC SERVICES, INCLUDING BUT NOT LIMITED TO, FUNDING A LONG-TERM CARE ASSISTED LIVING FACILITY, CONTINGENT ON BOTH THE PASSING OF REFERENDUMS 1A AND 1B AND THE COMPLETION OF THE ACQUISITION OF PRAIRIE PINES ASSISTED LIVING FACILITY BY KIOWA COUNTY HOSPITAL DISTRICT; AND SHALL THE KIOWA COUNTY HOSPITAL DISTRICT BE ENTITLED TO COLLECT, RETAIN, AND SPEND THOSE REVENUES IN ADDITION TO ANY OTHER TAXES, FEES, OR OTHER REVENUES OF KIOWA COUNTY HOSPITAL DISTRICT AS A VOTER APPROVED REVENUE CHANGE AND EXCEPTION TO ANY SPENDING OR REVENUE RESTRICTIONS OR OTHER LIMITS CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION; AND SHALL ALL OF THE TERMS AND CONDITIONS HEREIN BE PERPETUAL IN DURATION UNTIL AMENDED?
